i, your birth name in lower case, being preeviously unlawfully iddentified by the Union States Society Of North America – U.S.A. ande by the UNITED STATES CORPORATION COMPANY ande its agents principals heirs assignes ande any deerivatives thereof, unnder the colorable wardship name of birth name printed in black with first letters capitalized, ande the CORPORATE NOM DE GUERRE WAR NAME of YOUR BIRTH NAME IN ALL CAPITALS, or ANY OTHER NAME USED, do hereby reebut thee fraude ande proclaime my true soveraigne status. i deeclare ande affirme my true status ande that i, your birth name in lower case, am alivve ande in propria persona sui juris, in proprio solo ande in proprio heredes, ande i proclaime my rightfulle lyfe ande my soveraigne moor american natione; in accorde withe my moorishe natione of northe weste amexem northe america, exxercising all of my bearthrightes having lawfullie konsented to ande proclaime my moorishe american nationalitie ande bearthrighte appellatione ande noblle livving title, in harmonye ande in accorde withe diuine law, thee unniversal soveraigne custums ande thee laws, ruelles, ande ussages of the moorishe diuine ande nationall muuvemente. beeing origeneall ande inndigeneous, ande parte ande parcell of the northe american lande by bloode line, by primogenitture, by bearthright, by natural bearth, by universal diuine law ande by inheritance. i hereby proclaim for the record, i have rebutted the presumed FOREIGN, Foreign CORPORATION/Corporation cognomen ande fictitious misnomer back to the colonially possessors of its peddegree. i am now rightfullie deeclaring, publishing, ande proclaiminge my own free nationall status, appellatione ande esstate, affirming my actuall, rightfulle, ande soveraigne status as decedens spiritum reeturned alivve', my moorishe american konsanguine bloode line ande nationall ande unniversal honoure. lett it be deeclared, knowne, published, ande reesolved that i am
